## **CAMDEN COUNTY HIGH SCHOOL PARKING FINES**

The following violations will result in a monetary fine. If a fine is incurred, the student must report to **STUDENT SERVICES** within two (2) days to answer the charge.

1. Parking on campus without a parking permit: first (1<sup>st</sup>) offense is \$8.00.
2. Parking in unassigned parking area: first (1<sup>st</sup>) offense is \$6.00.

Two (2) or more offenses will result in a doubling of the fine and/or loss of parking privileges for thirty (30) days or the rest of the semester.

All fines must be paid within two (2) school days of the date of notification or parking privileges will be suspended until the fines are paid. Students who receive a ticket for parking without a permit must pay all fines in full before receiving a parking sticker the following school year. **All delinquent fines will be added to the student's fine list in PowerSchool.**

I have read and understand the above parking fine procedures. I also agree that it is my responsibility to pay any fines I might incur within the time stated.

### PARKING/DRIVING RULES AND REGULATIONS

1. Parking and driving on campus is a **privilege** not a right.
2. The parking sticker must be placed on the driver's side windshield at the bottom and must not be blocked by any other stickers.
3. Student parking will be limited to the number of available parking spaces.
4. The cost of the parking sticker is determined by the location of the assigned space.
5. Students must park in their assigned areas.
6. Student must obtain a parking permit before being allowed to park on campus.
7. Student must get a temporary parking pass from the Student Services Office if the car he/she is driving is at an auto shop being serviced or if he/she will be driving a parent's vehicle for a short period of time.
8. Student will be charged a transfer fee of \$3.00 if he/she will be driving a different vehicle from the one that the sticker was purchased for.
9. **Student must obtain administrative approval before visiting the parking lot during school hours.**
10. The maximum speed limit for automobiles on the school campus is 15 mph. **The school is NOT RESPONSIBLE OR LIABLE in any way for any accidents that may occur with automobiles driven to or from school or theft/vandalism while on the school campus.**
11. Parking violations will be handled by ladder punishment or by suspension of parking/driving privileges.
12. Speeding, reckless, driving, being habitually tardy, vandalism of other vehicles, improper sticker and other violations may result in loss of driving/parking privileges for a designated amount of time
13. Vehicles on campus are **subject to search at any time** by school officials.
14. Students must turn sound systems off while on school property or entering or leaving campus.
15. Parking stickers are **not** to be transferred from one vehicle to another or from one driver to another.
16. Ninth grade students will **not** be allowed to drive to school.
17. The following will result in the loss of driving privileges:
  - (a) Students that are **absent 5 times in a semester** period will lose their driving privileges for 30 school days or the rest of the semester. Refer to the attendance policy in the student handbook.
  - (b) Students **tardy to school 15 times** will be assigned 1 day ISS and will lose their driving privileges for 30 school days or the rest of the semester.
  - (c) Students that are retained after 2015-16 school year will **NOT** be issued a parking sticker the 1<sup>st</sup> semester of the 2016-2017 school year.
  - (d) Students that leave campus without permission or transport other students off campus without permission will lose their privileges for 30 days or the rest of the semester.
18. When a parking sticker is revoked it will be removed from the student's vehicle and a \$3.00 Fee will be charged before the student is issued another sticker.
